Entity Information

Legal Name of Entity: The Armstrong and Arthur Charitable Trust for Lesbians

Type of Entity and Legal Basis: Charitable Trust (Incorporation no 1180824)

Registration Number: CC10947

Entity's Purpose:

The purposes and aims of the Trust are to devote or apply both capital and income of the Trust Fund to or for any charitable purposes for the benefit of lesbian community groups in the Wellington region or individuals organising projects that benefit the lesbian community in the Wellington region, such purposes which are from time to time selected by the Trustees are valid charitable purposes.

Without limiting this in any way such purposes may also include:

- (a) education, research, and social development;
- (b) assistance of lesbian individuals and lesbian community groups and services which benefit the lesbian community such as helplines, library facilities, radio programmes, art exhibitions and theatre productions, and other cultural activities intended to further community development; and
- (c) provision of other services such as rehabilitation and health activities. Subject to clause 2.2(ii) the Trust may also devote or apply both capital and income of the Trust Fund to a separate fund to further charitable purposes for the benefit of lesbian women living in New Zealand.

Entity Structure:

The Trust operations are managed by the Trustees. The Chair, Secretary, and Treasurer are appointed by the Trustees, from the Trustees.

Main Sources of the Entity's Cash and Resources:

The Armstrong and Arthur Charitable Trust for Lesbians was established in 2001 by the late Bea Arthur for the benefit of lesbian community groups in the Wellington region. The Trust capital is made up of the settlement amount and subsequent bequests.

The main source of revenue for the Trust is income derived from the Trust Fund capital investments

From time to time the Trust receives donations, which is treated as capital and/or income at the direction of the donor. If no direction is received, the Trustees determine how to apply the donation.

Main Methods Used by the Entity to Raise Funds:

The Trust is not an active fundraiser. The donations and bequests it receives generally are unsolicited.

Entity's Reliance on Volunteers and Donated Goods or Services:

The Trust relies on gifts of volunteers' time. All the Trustees are volunteers.

for the year ended 31 March 2020

The Trust is a Tier 4 organisation as its turnover is less than \$125,000. The Performance Report meets the annual reporting requirements needed for Charities Registration compliance. Tier 4 organisations are not required to undertake an annual audit or review of their accounts; the Trust's Deed was amended accordingly (11 March 2019).

Term investments that matured during the year were rolled over for the same terms. However, interest rates continued to fall.

All investments were made in accordance with the Trustees Investment Policy.

In view of the declining income from the Trust's investments, the Trustees decided it was prudent to hold only one grant funding round during the financial year.

The Statement of Commitments shows the 2019/20 grants totalling \$6,750.00 which will be paid in the 2020/21 financial year.

CHAIR'S REPORT FOR THE YEAR ENDED 31 MARCH 2020

There are several activities and points worth noting for this reporting year.

In May 2019, Fran presented a short information piece on The Armstrong and Arthur Charitable Trust for Lesbians, which she was asked to prepare for inclusion in a new edition of a book entitled "Women Together: A History of Women's Organisations in New Zealand". First published in 1993, the publication comprises accounts of women's organisations established prior to 1993. The updated version covers groups started after 1993, including the Trust. "Women Together – Ngā Rōpū Wāhine o te Motu" is also available online at www.nzhistory.govt.nz/women-together.

In November 2019, we reluctantly farewelled long-serving Trustee Tighe Instone who retired from the Trust. Appointed on 22 May 2005, Tighe was an active and supportive Trustee. Her input into meetings was always carefully considered and well expressed. She frequently volunteered to help with Trust activities such as Out in the Park, often travelling from Tangimoana to do so. Her warmth, enthusiasm, and humour will be missed. We wish her all the best and an enjoyable retirement nearer to Wellington.

Ongoing work assessing the contents of the Trust's storage unit that began last year continued this year. In December 2019, Valda, Glenda, and Linda located and removed several items not directly relevant to Bette and Bea such as a large tin trunk, framed prints, an old medical bag, and a mirror. These were offered for sale or donation.

Final decisions regarding some personal belongings of Bette and Bea, such as Bette's World War 2 Red Cross nursing cape and Bea's medical material, are yet to be made.

Also remaining are the six large containers of back copies of Circle magazine (published 1973–1985), as well as one container of 1970s Gay Liberation material. General consensus agreed that careful disposal to new homes for the material was desirable. The Charlotte Museum in Auckland expressed interest in taking some of the Circles. The National Library as well as other identified institutions might be interested in filling gaps in their holdings. LAGANZ may take the Gay Liberation material. Disposals from the Trust's storage will resume in the next reporting year.

Trustees' opinion, however, was divided on whether to continue to hire storage space for the archives or whether to divide materials by type for storage in Trustees' houses. Although commercial storage is an ongoing drain on Trust funds, it does offer a centralised solution.

For almost 14 years, The Trust has contributed financially to the Lesbian Information and Archives Centre (Lilac) that is based in Wellington. A number of Trustees, and former Trustees, are past Lilac Collective members with several remaining current members. In October 2020, Lilac will celebrate its 25th anniversary: an historic event. We are pleased to support this significant service for same sex attracted women.

REPORT FROM A GRANT RECIPIENT

It is a condition of all grants that a report is provided to the Trust at the conclusion of a project or, for ongoing activities, at six-monthly intervals. Information provided here is taken from those reports.

LILAC Inc

The Lesbian Information Library and Archive Centre has the largest accessible collection of lesbian books and other materials in New Zealand and, the collective understands, in Australasia and in some European countries. It has been open almost continuously since September 1994, and is regarded as an important and invaluable resource and lesbian space in the Wellington region. Visitors from overseas admire and are envious of the facility.

Costs of maintaining LILAC (rent, power, new purchases/acquisitions) are met from subscriptions, fundraising events, and grants. A fundraising group was formed towards the end of 2019. They aim to focus on raising and applying for funds throughout the year.

Successful evening meetings were held during the year, including the opening of an exhibition of Sue Alexander's *Retro Lesbian Postcards*, and a panel discussion and Q&A session about the experiences of three lesbians in the construction industry.

A Book (and cake) Club meets once a month for discussion about specific authors or books, which is also an enjoyable social evening. Collective members take a selection of books, DVDs, and magazines to the monthly Coasters pot-luck dinners for members to borrow for a month. This service is greatly appreciated by women living on the Kapiti Coast.

WEBSITE REPORT

It was a quiet year for the website. Two posts were published, one in the News page and the other in the Apply for a grant page. This low activity was also reflected in the number of visits to the website. Page views of 1134 were down on previous years by 44%. The most visited pages were the Home page, Apply for a grant page, and News page.

Most visitors (48%) were from New Zealand, followed by Canada and USA. The age demographics were evenly distributed across all age groups. The technology used to access the website was 50% Windows (desktops or laptops), followed by android phones and Apple phones; this indicates a lot of people access on mobile devices.

Overall website activity by the Trust was low, and traffic to the website reflected this.
