#### **Entity's Purpose:**

The purposes and aims of the Trust are to devote or apply both capital and income of the Trust Fund to or for any charitable purposes for the benefit of lesbian community groups in the Wellington region or individuals organising projects that benefit the lesbian community in the Wellington region, such purposes which are from time to time selected by the Trustees are valid charitable purposes.

Without limiting this in any way such purposes may also include:

- (a) education, research, and social development;
- (b) assistance of lesbian individuals and lesbian community groups and services which benefit the lesbian community such as helplines, library facilities, radio programmes, art exhibitions and theatre productions, and other cultural activities intended to further community development; and
- (c) provision of other services such as rehabilitation and health activities. Subject to clause 2.2(ii) the Trust may also devote or apply both capital and income of the Trust Fund to a separate fund to further charitable purposes for the benefit of lesbian women living in New Zealand.

#### **Entity Structure:**

The Trust operations are managed by the Trustees. The Chair, Secretary and Treasurer are appointed by the Trustees, from the Trustees.

#### Main Sources of the Entity's Cash and Resources:

The Armstrong and Arthur Charitable Trust for Lesbians was established in 2001 by the late Bea Arthur for the benefit of lesbian community groups in the Wellington region. The Trust capital is made up of the settlement amount and subsequent bequests.

The main source of revenue for the Trust is income derived from the Trust Fund capital investments.

From time to time the Trust receives donations, which is treated as capital and/or income at the direction of the donor. If no direction is received, the Trustees determine how to apply the donation.

#### Main Methods Used by the Entity to Raise Funds:

The Trust is not an active fundraiser. The donations and bequests it receives generally are unsolicited.

#### Entity's Reliance on Volunteers and Donated Goods or Services:

The Trust relies on gifts of volunteers' time. All the Trustees are volunteers.

## The Armstrong and Arthur Charitable Trust for Lesbians Treasurer's Report

### for the year ended 31 March 2018

The Trust is a Tier 4 organisation as its turnover is less than \$125,000. The Performance Report meets the annual reporting requirements needed for Charities Registration compliance.

During the year two term investments matured. The impact of fluctuating interest rates for term investments was very clear.

- ASB 12-3157-00101778-0073: \$25,000 matured on 13 May 2017. It was reinvested for two years with an interest rate of 3.9% per annum paid into the Trust current account quarterly. The interest on the investment that matured was 4.4% per annum.
- BNZ 65367113-00001: \$10,000 matured on 31 July 2017 and was reinvested until 27 April 2018 with an interest rate of 3.6% per annum paid at maturity. The interest on the investment that matured was 3.4% per annum.

All investments were made in accordance with the Trustees Investment Policy.

In view of the declining income from the Trust's investments, the Trustees decided it was prudent to hold only one grant funding round during the financial year.

The Statement of Commitments shows the 2018/19 grants totalling \$6,000 which will be paid in the 2018/19 financial year. A bank error meant that the last four-weekly payment of the 2017/18 Lesbian Radio Programme Access Radio Fees grant of \$184.00 was paid in the 2018/19 financial year.

#### Report on the Armstrong and Arthur Charitable Trust for Lesbians 2018 Financial Statements

I have reviewed the 2018 Annual Financial Statements of the Armstrong and Arthur Charitable Trust for Lesbians, which comprise the Statement of Resources and Commitments as at 31st March 2018, the Notes to the Performance Report for the year ended on that date, and a summary of other explanatory information.

#### Responsibility

My responsibility is to express a conclusion on the 2018 Annual Financial Statements based on my review. I conducted my review in accordance with NZ SRE 2400 *Review of Financial Statements Performed by the Independent Auditor of the Entity.* NZ SRE 2400 requires me to conclude whether anything has come to my attention that causes me to believe that the financial statements, taken as a whole, are not prepared inall material respects, inaccordance with acceptable accounting standards in New Zealand.

A review of annual financial statements in accordance with NZ SRE 2400 is a limited assurance engagement. The auditor performs procedures, primarily consisting of making enquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures.

The procedures performed in a review are substantially less than those performed in an audit conducted in accordance with International Standards on Auditing (New Zealand). Accordingly I do not express an audit opinion on those financial statements.

Other than in my capacity as assurance practitioner I have no relationship With, or interests in, the Armstrong and Arthur Charitable Trust for Lesbians.

#### Conclusion

Based on my review, nothing has come to my attention that causes me to believe that these 2018 Annual Financial Statements of the Armstrong and Arthur Charitable Trust for Lesbians are not prepared, in all material respects, in accordance with acceptable accounting standards in New Zealand.

## CHAIR'S REPORT FOR THE YEAR ENDED 31 MARCH 2018

From time to time, Trustees receive requests from within our communities for information specifically about our founders Bette Armstrong and Bea Arthur. This reporting year confirmed an infrequent but ongoing interest. Increasingly, demands for images accompany these requests. The interest is heartening, especially as The Armstrong and Arthur Charitable Trust for Lesbians nears the end of its second decade. We think it appropriate that Bette and Bea appear in the rainbow historical record of Wellington.

In response, Trustees embarked on a long-term project to make available selected images, accompanied by biographical data, of Bette and Bea on our website. The project draws on material held in the Trust's small archive, which comprises photograph albums, sketch books and notebooks, as well as numerous recipe books. The contents of some of the last were interesting in that they demonstrated changing dietary patterns and food preparation in New Zealand Aotearoa during the second part of last century.

Earlier in the year, several recipes favoured by Bette and Bea were posted on the Trust's website under a webpage entitled Cooking Capers. As noted there, the couple enjoyed entertaining at home, frequently holding dinner parties and afternoon teas. Their preparation drew on a number of recipe books or hand-copied recipes. Many books contain annotations, including which guests received a particular dish and when.

Unsurprisingly, Trustees enjoyed perusing this material and selecting the next 'batch' of recipes to be posted. The process stirred memories in many of us relating to school domestic science classes. Others recalled past culinary fashions. Thanks to Trustees Rosie and Kay for selecting the first choices.

One of the Trust's annual commitments is to support Out in Park, which was held on a very sunny 24 February 2018 at Waitangi Park in Wellington. Thanks to Rainbow Wellington for paying our stallholder's fee at the well-attended day.

This year, our table displayed two large boards of selected copied photographs of Bette and Bea each as young women prior to their meeting, and then throughout their long relationship. The images proved to be highly popular with a large range of visitors. Some appreciated the photograph that showed Bette and Bea standing in, what has become, Waitangi Park with the Chaffers Building in the background. Now an apartment building, this provides a backdrop to Out in the Park.

As well as questions and comments about the photos, we received several enquiries about the A & A Trust including making bequests. Other visitors made direct donations that were also very welcome. Thanks to Trustees Glenda and Rob for answering lots of questions when staffing the table. Also cheers to Rob for appearing as the face of the A & A stall on Facebook.

The Trust's photo boards displayed at Out in the Park also provided an opportunity for feedback on the images selected, giving Trustees Glenda and Valda a good indication of the most popular ones. These images are likely to be scanned and posted first. One or two will likely be reproduced in the future as postcards. This first step was made easier by the earlier

work of Trustees Linda and Alison, who had chosen and copied original photographs for earlier displays.

Examining a sample of archival material throughout this year provided Trustees with a glimpse of the domestic and social life of the founders of The Armstrong and Arthur Charitable Trust for Lesbians. Although it is a limited collection, it may prove to be a rich cache of cultural history.

## **REPORTS FROM GRANT RECIPIENTS**

It is a condition of all grants that a report is provided to the Trust at the conclusion of a project, or, for ongoing activities, at six-monthly intervals. Information provided here is taken from those reports.

#### S. Torrington

Wellington artist Siân Torrington initiated and undertook a community engagement arts project which examined lesbian involvement in homosexual law reform law reform as a prism for exploring queer sexuality, as well as strategies and experiences of lesbian activism in public space. Archival material, interviews, and hui formed the basis of visual and written work for the light-boxes in Courtenay Place in August 2016 plus a publication.

The project yielded a much greater community response than was anticipated, with invitations to take the work to Auckland as part of the Pride Festival and later to hold a hui at Te Papa, both in 2017. These events contributed material to the publication, which was completed in September 2017.

#### Lesbian Community Radio Programme

The weekly radio programme is produced by a large collective of presenters and technicians and broadcast on Wellington Access Radio. During the year Access changed frequency from AM to FM 106.1. This give reduced geographical live access, but the collective has found that the programme is now listened to more from downloads than live on Sunday mornings. Each programme is available for downloading for about six weeks after its broadcast date. The collective maintains a Facebook page, with links to webpages discussed in programmes, which generates much interest and interaction.

Collective members took part in Out In The Park, both in the march and with a stall, providing publicity.
